PURPOSE: This scholarship has been implemented with the intention of aiding a student who meets the eligibility requirements and is planning to attend an institution of higher learning. The scholarship is applicable towards tuition, books, room and board, etc.

SCHOLARSHIP AMOUNT: This is a \$1,000.00 non-renewable scholarship.

ELIGIBILITY REQUIREMENTS: The applicant must be a graduating senior residing in Lake County and must be a member of a Lake County 4-H organization or a member of the Lake County Junior Fair Board.

APPLICATION CHECKLIST: Please ensure the following items are included.

- 1) The completed application
- 2) An official school transcript including the most recent grade reporting period
- 3) Proof of admission to an institution of higher learning as a full-time student
- 4) An essay summarizing school and community activities and worthiness
- 5) A high school reference
- 6) A community reference

DUE DATE: Applications must be postmarked by April 1, 2020. The scholarship winner will be announced on April 16, 2020.

JUDGING: The decision of the Scholarship Committee Judges will be final.

AWARD: Prior to receiving the scholarship funds, the recipient must present an official transcript from the school reflecting a 2.5 grade point average or higher for the first grading period.
